He welcomed the members and requested to present their credentials. The Chairperson called the meeting to order and requested the Secretary to proceed with the agenda.

# Item No. 1. To consider and confirmation of the Minutes of the Last Annual General Meeting of the Sports Board, D.U. held on 19<sup>th</sup> July 2016.

#### Discussion:

The minutes of the last Annual General Meeting of the Sports Board held on 19<sup>th</sup> July 2016 was circulated to the members in advance. The Chairperson requested the members of the meeting to go through the Minutes of the last meeting and point out omission and commission, if any.

#### Discussion:

The Finance Committee proposed to collect the students affiliation fee course wise i.e. @ Rs. 30 x 3years = 90/- x number of students for three year course and etc. In this context, Dr. Mantu Baro, Secretary, Sports Board pointed out about the probable difficulties in the collection of fee by the affiliated colleges in terms of discontinuation of course by students etc. The house had threadbare discussion on the matter.

As recommended he the Treasurer also place regarding the collection of annual affiliation fee from the students who are pursuing PG courses and other courses of minimum one year duration affiliated to and offered by Dibrugarh University in the respective colleges.

The Secretary, DUPGSU Mr. Manash Pratim Dutta in Finance Committee meeting proposed to invite at least one international level sports person or outstanding personalities in every 5 year with a purpose to bring popularity, name and fame of the University in the national and international level as well as to attract the university students towards participation in co-curricular activities.

After threadbare discussion, the House agreed and decided to adopt the following resolution.

He also informed about the proposal of Mr. Anjan Chetia, Secretary, DUEA to introduce Karate the form of Martial Art as event of the Inter College competition/tournament from the session 2017-18.

The Board has gone through the draft Annual Sports Calendar of D.U. Sports Board 2017-18 and the applications of the Colleges desiring to host the Inter College Tournament / Competitions. Secretary also inform to the House about the vacant venue of few inter college events. After threadbare discussion, the House considered the draft Annual Academic Calendar and adopted the following resolution.

Item No. 11. To discuss and confirm the constitution of panel of selectors/observers of D.U. team in various sports/cultural events.
