The Chairperson extended a warm welcome to all the Members present in the 112th Meeting of the Academic Council (Special) held on 26.10.2017 (Thursday) at the Indira Miri Conference Hall, Dibrugarh University. The Chairperson requested the Secretary to present the agenda items. On behalf of the Secretary, the Deputy Registrar (Academic) placed the matters as below.

Item No. 01: To recommend the Panels of the Chief Guest and *Honoris causa* (D.Sc. and D. Lit) of the XVII Convocation 2017.

Discussion: The Chairperson requested the Hon'ble members to propose panels of eminent persons for extending invitation to the XVII Convocation as the Chief Guest subject to approval by the Hon'ble Chancellor. Item No. 02: To consider the Draft of the New Admission Rules for Foreign/NRI Students to the various Academic Programmes of Dibrugarh University.

Discussion The Deputy Registrar (Academic) placed the Draft of the New Admission Rules for Foreign/NRI Students to the various Academic Programmes of Dibrugarh University as recommended by the Director, Office of the International Affairs. The Council discussed the matter and recommended the same to the Executive Council for approval.

Resolution No. 2 Resolved to recommend to the Executive Council that the Draft of Admission Rules for Foreign/NRI Students to the various Academic Programmes of Dibrugarh University be considered for approval.

Item No 03. To consider introduction of Masters Programme in Sanskrit in Dibrugarh University

Discussion The Deputy Registrar (Academic) placed a letter received from the Director of Higher Education, Assam requesting the University for Introduction of Masters Programme in Sanskrit in Dibrugarh University. The Council discussed the matter and appreciated the appeal of the Government. However, the Council opined that introduction of a new academic programme with a new set up is feasible provided the University gets concurrence of at least four teaching positions from the Government for the proposed department.

Resolution No. 03 Resolved that as advised by the Director of Higher Education,
Assam, the introduction of Masters Programme in Sanskrit in
Dibrugarh University be approved in principle.

Resolved further that the Government of Assam be requested to sanction at least four (4) teaching positions to run the Masters Programme in Sanskrit in Dibrugarh University.

Resolved further that the J.B. college, Jorhat be advised to take necessary action for introduction of the Masters Programme in Sanskrit.

Item No 04. To consider enhancement of seats for the Tea and Ex Tea Community students for admission into the M.A/M.Sc./M.Com Programmes.

Discussion

The Deputy Registrar (Academic) placed the matter of the enhancement of seats for the Tea and Ex Tea Community students for admission into the M.A/M.Sc./M.Com Programmes proposed by Ms Bondita Sasoni, Hon'ble Member of the DU in the 99th Meeting of the Hon'ble DU Court held on 25.10.2016. The Council discussed the matter and opined that the matter is a subject of further deliberation and scrutiny as it might have different implications in the entire non-statutory reservation system of the University. The Council noted the advice of the Hon'ble Court and accepted for further deliberation by an Expert Committee.

Resolution No. 04 Resolved that the proposal for creation of more reserved seats for the Tea and Ex-Tea Community students in different Academic Programmes as advised by the Hon'ble Court be accepted in principle.

Resolved further that a Committee be constituted to examine the feasibility for creation of more reserved seats for the Tea and Ex Tea Community students in different Academic Programmes of the University.

Item No 05. To consider upgrading the Six Months Certificate Programme on North East India to a One Year Post Graduate Diploma Programme on North East India conducted at the Omeo Kumar Das Institute of Social Change and Development, Guwahati, Assam.

Discussion The Deputy Registrar (Academic) placed the letter received from the Director, Omeo Kumar Das Institute of Social Change and Development, Guwahati, Assam requesting to consider upgradation of the Six Months Certificate Programme on North East India to a One Year Post Graduate Diploma Programme on North East India. The Council discussed the matter and recommended approval on the same.

The Deputy Registrar (Academic) apprised the Council that the One Year B.Ed Programme of Dibrugarh University was run only for an academic session, i.e. 2015-2015. After that, the B.Ed. Programme became two years or of four semesters. However, few candidates could not clear their examinations within the normal chances and no scope was there to avail a special chance to clear the backlog papers. In view of this, in consultation with the Controller of Examinations, a special examination for the failed candidates was proposed.

The Council discussed the matter and recommended the same for approval.

Resolved that as recommended by the Dean, School of Education, a Special Chance to the failed Candidates of the One Year B.Ed. Programme (session 2015-2016) be approved without creating precedence.

Resolved further that the Controller of Examinations be requested to conduct a special Examination for the failed candidates of the One Year B.Ed. Programme (session 2015-2016) examining feasibility of it.
