NOTIFICATION

In view of the Guidelines for home quarantine of the Government of Assam under unlock-3.0, for COVID-19 and as subsequent recommendation of the Committee constituted for Monitoring Home Quarantine cases in the Dibrugarh University, it is hereby notified for information of all Teachers, Officers and Employees of Dibrugarh University to kindly abide by the following rules:

- 1. All Teachers, Employees and Officers shall have to inform the Security Officer (duly authorized for the purpose) regarding the quarantine issues in their families, if any, at the earliest.
- 2. The Families / Persons already in quarantine shall have to follow strictly the guidelines and advisories issued by the Government of Assam as well as Central Government time to time.
- 3. Under the initiative of the Senior Medical Officer, Dibrugarh University, the Area Surveillance Officer, appointed by the District Administration will visit the quarantine families/person from time to time for monitoring and providing necessary medical assistance.
- 4. Entry into the University by the visitors / students is strictly prohibited till 20.08.2020 (in exceptional cases visitors may enter the campus with the permission from the Security Officer). However, the domestic helps may be allowed with proper sanitization and Temperature check at the main gates of the University campus. Temperature checking, sanitization, submissions of travel details to the security personnel at the entry point are mandatory for all persons and to be strictly adhered.
- Contractors of various constructions inside the University Campus are advised to provide a detailed list of the workers engaged in respective construction sites. They are further advised to confine the movement of workers inside the construction sites. Constructions related to Government Project or highly essential will only be allowed.
- 6. All teachers, employees and officers residing in the Dibrugarh University Campus are advised to travel under absolutely urgent / emergency situations only. Further, if resident/s from University Campus visits the places where community spread/containment zone have been reported or their relatives from the other states/ districts of Assam where community spread/containment zone have been reported visit for a stay at University Campus, then such resident, visitors and the hosts shall mandatorily have to follow seven days of self-quarantine at their residences upon permission to enter.
- 7. The Vendors, courier delivery personnel etc. are prohibited from entering into the University campus up till 20.08.2020.
- 8. The office of the University will run on 50% of employees (on rotational basis) till 20.08.2020. However, the employees must be available on call as and when required.
- 9. All teachers, officers and employees are requested to download and install AAROGYA SETU app for information relating to COVID-19.
