***Subject: Regarding Offering of Skill Enhancement Courses (SECs) in the B.A., B.Sc., and B.Com. Programmes in CBCS***

Dear Sir/ Madam,

With reference to the above and as approved by the Hon'ble Vice-Chancellor, Dibrugarh University, I would like to inform you that the University is yet to notify the detailed Syllabuses of the SECs as mentioned in Annexure II of the Regulations concerned. It may be pertinent here to mention that the subjects enlisted in Annexure II of the Regulations are offered as the Skill Based Courses in B.A. and B.Sc. Programmes in Non-CBCS. Hence, for convenience as well as considering the relevance of these subjects, the University in principle has decided to offer these courses as SECs in CBCS as well as per the existing syllabi converting the same into 2 credit courses.

In context of the above, you are requested to comply with the following-

1. The SECs should be offered as per the Annexure II of the DU Regulations for the BA, B.Sc., and B.Com Programmes in CBCS.
2. The concerned Boards of Studies are/will be requested to restructure these Syllabi into credit mode with 2 credit each. ***In the meantime, the Colleges may offer these courses to the students with the existing syllabi of Non-CBCS.***
3. Besides the 17 subjects enlisted in Annexure II of the Regulations, SECs may also be offered in the following subjects (Syllabi enclosed)-
  - a) NSS
  - b) Library and Information Science
4. Besides the subjects above, there are some other SECs notified along with Core and Elective Courses of different disciplines. These Syllabi are also approved by the


University in principle, but for convenience of conduct in present circumstances, we suggest to confine the choices of the students within the subjects mentioned in Annexure II of the Regulations and Point 3 of this Letter.

5. It may kindly be noted that the contents and structure of the syllabi of SECs may be slightly changed along with conversion to credit mode and that will be notified later on.

The matter may kindly be treated as very urgent and you are requested to kindly coordinate with the concerned departments in offering and conducting the SECs effectively.


