It is hereby notified for information of all concerned that the web portal for Examination Form Fill-up for the B.A./B.Sc./B.Com.1st & 3rd Semester (CBCS) Examination, 2020 under Dibrugarh University (to be held in the month of March - April, 2021) will open from 08.03.2021.

The colleges and students are requested to follow the below mentioned steps at the time of online Examination form Fill-up:

STEPS TO BE FOLLOWED BY THE COLLEGES

- 1. Log into your account with the same user name and password provided to you earlier.
- 2. Click on Exam Forms menu and then on Exam Form List.
- 3. Select Drop-down Menus- Session, Course, Branch, Exam and Status. Please choose the Pending status.
- 4. A list of candidates will appear in the screen. Select the Approve option from the Action menu for the student who is eligible to pay the Examination fees to the University.
- 5. Please click the Checkbox button (a tick mark appears on clicked) in the Non-Collegiate column for the student who has to pay the Non-Collegiate Fee to the University; otherwise please leave it blank.
- 6. Click the Save button on the top of the Exam Forms student List. Now the student can view the Pay Now button after the student log-in.
- 7. Repeat the above steps for all the eligible students.
- 8. A student may be barred from applying an examination form by clicking the Not Approve option from the Action menu.
- 9. Complying Office Memorandum No. AHE.639/2018/16 Dated, Dispur the 10th June, 2020, the examination fee for the Academic Session 2020 2021 of 1st and 3rd Semester regular students (domicile from Assam) having Unique id assigned by DHE and studying only at various Govt./ Provincialised (under Directorate of Higher Education) Colleges and Institutes under the territorial jurisdiction of Dibrugarh University are hereby waived off. However, the benefit of fee waiver will not include non govt. / non provincialised Colleges / Institutes and the self financing courses of the Colleges / Institutes. In this regard, the 1st Semester Backlog students cannot claim for the fee waiver.

Note: Please complete the process as early as possible so that eligible student can make online payment for the examination form fill-up fees. In case of Action status – Pending or not Approve, a student cannot make payment of fees. The amount of examination form fill-up fee includes Examination fee, Backlog Course fee, Mark sheet fee, Non-collegiate fee and Late fine fee (if applicable) only. Other fees like University Centre fee & Practical examination fee have to be collected from students by the college itself.

STEPS TO BE FOLLOWED BY THE STUDENTS

Login into the TDC 1st (Regular and Backlog) and 3rd Semester (Regular) (CBCS) examination form fillup through web portal www.dibruexam.in. The username (mobile number) and password are the same that has been created during the registration process

into the Dibrugarh University through online mode Enter the mobile no. and the password used at the time of registration for log-in.

- 2. After successful login, if you are appearing for two examinations say B.A. 1st Semester (Backlog) and B.A. 3rd Semester (Regular) Examinations, then fill-up the form twice. If you are appearing for a single examination like B.S. 3rd Semester (Regular) Examination only then fill-up the form once. You can fill-up the form by clicking on the exam form link after the login under the action section.
- 3. Confirm your domicile status of Assam and enter your Unique ID (assigned by DHE, Assam), if available and applicable.
- 4. Submit exam form.
- 5. Exam form will be verified by respective colleges/Institutes.
- 6. After college/institute verification make online payment(if applicable). If you are pursuing a Govt approved Programme from a Govt/Provincilaised College/Institutes and domicile from Assam and have a valid Unique ID, you are not required to pay any fees. After verification of your examination form by your college/institute, you will get a receipt describing the waived off details. Otherwise, you have to pay the requisite fees.
- 7. After successful online payment, download payment receipt and keep it safe for your future reference.

**Applicable for those candidates who do not have requisite attendance as per clause 5 of Dibrugarh University Regulations for the Under-Graduate Academic Programmes in the Choice Based Credit System (CBCS), 2018.

- Minimum 80% attendance is necessary to appear in the End Semester Examination.
- A student who has attended a minimum of 70% classes but failed to obtain the prescribed 80% attendance for valid reasons shall have to pay the Non-Collegiate fees.
- Students having less than 70% attendance are not allowed to appear in the End Semester Examination and those student shall be declared as discollegiate.
