DIBRUGARH UNIVERSITY REGULATIONS FOR THE DEGREE OF DOCTOR OF LITERATURE (D. LITT.) AND DOCTOR OF SCIENCE (D. SC.) 2020

[Recommended by the 12th Meeting of Research Council held on 04.03.2021 and recommended by the 121st Meeting of Academic Council held on 09.03.2021]

(Notified vide Memo No.: DU/DR-A/8-1/21/299 dated 10.03.2021)

1. Eligibility

A Scholar having a Ph.D. degree of Dibrugarh University or an equivalent Degree of any other University duly recognised by Dibrugarh University may apply for registration for the degree of D. Litt/ D. Sc. not before three years after obtaining Ph.D.

2. Registration

A candidate shall apply on prescribed proforma (Annexure- I) together with a prescribed fee (Annexure- II) to the Joint Registrar (Academic) for the degree of D. Litt./ D. Sc..

The application for registration must be accompanied by –

- a. Four copies of outline of the proposed work with plagiarism check certificate
- b. A signed statement giving the particulars relating to his/her contributions towards the advancement of knowledge on the subject
- c. Evidence of sustained research work during the intervening period (i.e. the period between getting Ph.D. and submission of application for registration) with supporting documents.

The candidate shall submit the following along with the application.

- i. Certificate of all examinations passed including Ph.D.
- ii. A chronologically arranged list of publications

Application for registration of candidates for the D. Litt/ D. Sc. degree shall be screened and processed by a Higher Research Degree Committee comprising the following members.

The term of the office of the committee shall be 3 (three) years. Function of the Higher Research Degree Committee:

- i. To screen the applications for registration;
- ii. To recommend a panel of examiners in consultation with the expert(s) in the respective field of specialisation after submission of the thesis;
- iii. All other functions as referred to under Clause 9 relating to evaluation.

The Joint Registrar (Academic), on the recommendations of the Higher Research Degree Committee, shall send the application of a candidate along with the relevant papers to two experts seeking opinion on suitability of the topic of Post Doctoral Research. The Joint Registrar (Academic) shall place the experts' reports in the Higher Research Degree Committee. If the experts' reports are found favourable, the candidate shall be recommended for registration by the Higher Research Degree Committee on payment of prescribed fee (Annexure-II). The Registration will be valid for 5 (five) years from the date of Registration.

3. Submission of Thesis

The registered candidate shall be eligible for submission of the thesis two years after registration. The candidate shall submit the thesis to the Controller of Examination for D. Litt/ D. Sc. in quadruplicate along with four copies of abstract and examination fee (Annexure-II). The format of the thesis is given in Annexure-III.

The thesis of the candidate may be either a fresh work or collection of the published papers or a published book of exceptionally high standard containing the results of sustained research after getting Ph.D. In case of submission of a published book, it should be written after getting the Ph.D. Degree. The medium of thesis/ book/ papers submitted for D. Litt/ D. Sc. shall be English. The thesis should also accompanied by Plagiarism Check Certificate issued from the LNB Library, D.U. Research papers submitted for the D. Litt/ D. Sc. degree should preferably be the work of a single author. In case of joint authors/ investigators, the Scholar concerned should be the Principal author/ investigator.

Provided that there must be a gap of minimum five years between the date of getting Ph.D. and the date of getting D. Litt/D. Sc.

While submitting the thesis, the candidate must certify that

- i. He/ She has fulfilled all the requirements under this regulation;
- ii. The work is the result of his/her investigation on the topic of research;
- iii. The thesis or any part of it is not submitted to Dibrugarh University or any other University for any research degree.

4. Evaluation

The Higher Research Degree Committee shall recommend a panel of at least five expert examiners out of which, at least two examiners should be from aboard. The Vice-Chancellor shall appoint three examiners from the panel that include at least one foreign examiner. The examiners shall independently submit reports to the Vice Chancellor, who

will, in turn, place the same before the Higher Research Degree Committee. The Higher Research Degree Committee shall recommend for the degree of D. Litt/ D. Sc. to the candidate by the Executive Council, if reports of all the three examiners are found satisfactory. The Executive Council shall award the degree on positive recommendation by the Higher Research Degree Committee.

In case, the thesis is not recommended by one examiner, the candidate may resubmit the thesis after revising it in the light of the suggestions made by the examiner concerned.

The revised thesis shall have to be submitted within two years from the declaration by the Higher Research Degree Committee by paying the prescribed examination fee. The examiner who evaluates the revised thesis shall recommend only either the acceptance or the rejection of the thesis and shall not recommend any further revision of the thesis.

If the thesis is not recommended by more than one examiner, it cannot be resubmitted. If the thesis is rejected, the candidate shall not be allowed to apply again for admission within a period of 4 (four) years.

5. General

Matters not covered by the above clauses, shall be decided as and when necessary by the Research Council/Joint Research Council/Academic Council/ Executive Council.

FORMAT OF THE THESIS

The following format may be normally adopted for the D. Litt./ D. Sc. Thesis:

- 1. Cover page
- 2. Inner cover page
- 3. Plagiarism check certificate
- 4. Declaration by the candidate as per the format given in Annexure- IV to the effect that the work has not been submitted for any other degree or diploma
- 5. Detail work and results of the thesis work
- 6. Bibliography/ References

The following will have to be submitted along with the thesis:

- 1. An Abstract of about 2000 words, describing the research work carried out during the last 5 (five) years (before the date of submission), on the subject relevant to the discipline in which the candidate has applied for the degree, explaining how far the work is original, exemplary and is contributive to the advancement of knowledge. It shall also summarize the relevance of the publications to the specific subject of the thesis being submitted.
- 2. Reprints of the published work by the candidate, in the relevant subject, in the form of research papers, abstracts/ books/ monographs, chapter contribution to books/ monographs and citations of candidate's work by others.
- 3. List of publications
- 4. A personal profile of the candidate with photograph, not exceeding one page.
