3. To take such follow up measures for achieving the objectives and targets laid down for the purpose by the Government of India and the UGC.
4. To implement, monitor and evaluate continuously the reservation policy in this University and plan measures for ensuring effective implementation of the policy and programme of the Government of India.
5. To function as a Grievances Redressal Cell for the Grievances of SC/ST students and employees of the university and render them necessary help in solving their academic as well as administrative problems.
6. The Committee shall remain valid for a period of 03 years or until further order whichever is earlier w.e.f. the date of issue of this notification.

This cancels the earlier Notification No. DU/RG/G.01.01/2021/4314 dated 19-03-2021.


