**Rules for Permission for Publication of the Awarded Ph.D. Theses by the Scholars:  
Dibrugarh University**

Under report to the Research Council and Academic Council, Dibrugarh University the Hon'ble Vice Chancellor, Dibrugarh University is pleased to approve the **Rules for Permission for Publication of the Awarded Ph.D. Theses by the Scholars, Dibrugarh University** with immediate effect. This Provision amends the Clause 31 of the Dibrugarh University Regulations for the Research Council and for the Degree of Doctor of Philosophy (Ph.D.) 2019 (amended up to date), as below-

**RULES FOR PERMISSION FOR PUBLICATION OF THE AWARDED Ph.D. THESES BY THE SCHOLARS: DIBRUGARH UNIVERSITY**

- a. *In pursuance of the Resolution No. 24 of the 121<sup>st</sup> Meeting of the Academic Council held on 09.03.2021, the Rules is approved by the Hon'ble Vice-Chancellor, Dibrugarh University under report to the Research Council and Academic Council, Dibrugarh University and subsequently notified vide Memo No. DU/ DR-A/8-1/414 dated 01.04.2021.*
- b. *This Rules amends Clause 31 of the Dibrugarh University Regulations for the Research Council and for the Degree of Doctor of Philosophy (Ph.D.) 2019 (amended up to date) and has been inserted in the Regulations as Annexure VIII.*

**A. General**

1. This Rule is prepared and adopted by Dibrugarh University on recommendation of the 121<sup>st</sup> Meeting of the Academic Council held on 09.03.2021.
2. This Rule will cover the matters of publication of the Ph.D. Theses by the intending Ph.D. Scholars on which Dibrugarh University has awarded the Ph.D. Degree to the concerned persons.
3. The term, 'Publication of Awarded Ph.D. Thesis' means publication of the Ph.D. Work by an intending scholar or by the University in the form of a Book or as Research Paper(s).
4. This Rule shall be applicable only on the Ph.D. Theses, on which Dibrugarh University has awarded the Ph.D. degrees to the concerned scholars.

**B. Rules for Publication**

1. The Dibrugarh University may accord permission to the concerned Ph.D. Scholar for publication of his/ her Ph.D. Thesis in the form of a book provided that-
  - a) At least two examiners (three in case of joint supervision) recommend for publication of the Thesis in the form of a book.
  - b) At least two examiners (three in case of joint supervision) recommend for publication of the Thesis in the form of research paper(s).
  - c) One of the examiners has recommended for publication of the Thesis in the form of a book or as research paper(s) and other two remained silent about it.
  - d) In case of joint supervision, at least two examiners recommend for publication whereas at least one examiner has not put any remark on it.

### **C. Procedure for getting Permission to publish the Ph.D. Theses:**

1. The intending candidates shall apply to the University through the Joint Registrar (Academic) for getting permission to publish his/ her Ph.D. Theses. The Application should contain a copy of the Notification of the Ph.D. Awarded by the University.
2. There shall be a Committee with the following Members for scrutiny of the Applications of the intending candidates-
  - a. The Dean, Research and Development, Dibrugarh University - Chairperson
  - b. The Registrar, Dibrugarh University - Member
  - c. The Controller of Examinations, Dibrugarh University - Member
  - d. The Joint Registrar (Academic), Dibrugarh University - Member- Secretary
3. The Joint Registrar (Academic) shall receive the Applications from the intending scholars and will collect the Reports of the Ph.D. Theses from the Office of the Controller of Examinations for necessary action.
4. On recommendation of the Committee, the Joint Registrar (Academic), Dibrugarh University shall intimate the intending scholars regarding approval or non-approval of the permission to publish his/ her Ph.D. Thesis.

### **D. Norms for Publishing the Ph.D. Theses:**

1. The Scholar who intends to publish his/ her Ph.D. Theses by himself/ herself or through a publishing house must obtain a Letter of Approval from the Registrar, Dibrugarh University.
2. The Author must acknowledge Dibrugarh University, when he/ she publish the outcome of the awarded Ph.D. research in the form of a Book in the Preface or Acknowledgement of the Book.
3. The Author shall neither use the logo of Dibrugarh University nor print the Copy of the Award Letter/ Certificate in the Book based on the Thesis.
4. The Author shall have to submit a Copy of the Book/ Research Paper at the Office of the Joint Registrar (Academic) before publishing for verification of the compliance of the norms.

### **E. Others:**

1. In extra-ordinary cases, the University may decide to publish the Ph.D. Thesis of a Scholar by the University itself. In such cases, the University shall duly communicate the author of the Thesis and shall obtain necessary prior permission from him/ her.
2. Any other matter or circumstances, not covered by this Rule shall be addressed by the Vice-Chancellor, Dibrugarh University with the power entrusted by Dibrugarh University Act, 1965 (amended up to date).
