Notification for Invitation of Proposals for Introduction of PG Programme

This is for information of all Government / Provincialized Colleges having ten years of minimum experience of running Honours Programme in the concerned subjects that they may submit proposals in the prescribed format (hard Copies) on or before 10th May 2022 positively (available in the website of the university) with payment of Application fees of Rs 1000.00(One thousand only) through demand draft in favour of the Registrar, DU/ NEFT with record of payment subject to fulfillment of the conditions on the date of submission of proposals with all necessary documents and declarations by the Principals and resolutions of the G B of the Colleges, for the session (2022-23) as mentioned below,

(1) Minimum regular no of teachers holding positions against sanctioned posts in the Affiliated Provincialized/ Government Colleges for introduction of P.G Programme shall be **04(four) in the Department concerned with minimum** (02) two Associate Professors and minimum (02), two Asst. Professors . At least two of them shall be with PhD in the concerned /allied / relevant subject.

(2) The colleges shall appoint at least 03(three) more Full time qualified teachers to conduct P.G Classes to fulfil minimum requirement of at least 07(seven) teachers for the same, if permission/ provisional permission is accorded within the stipulated period to be mentioned in the order.

(03) The colleges with more than (04) Teachers holding positions against Sanctioned Posts with at least 03(three) of them with PhD and only one Associate Professor in the concerned Department , if submit Proposal for PG Programme , the same shall be placed before Affiliation Committee for consideration of grant of permission subject to fulfillment of other requisite conditions.


(04) The Principals and Head of the Department of the concerned colleges may require to be present during scrutiny of the proposals at university on the stipulated date to be informed and shall pay Rs 5000.00(Five thousand) as provisional permission Fees if provisional permission is accorded by the University at the time of receiving permission order.

(05) The Inspection Committee may also visit the colleges before according permission and shall have to pay fees as per rules if permission is accorded.

(06) The colleges shall offer Courses on Generic Elective and Ability Enhancement with sufficient no of qualified teachers against sanctioned posts with PhD and shall mention the same in the proposal with evidence in a separate sheet mentioning name, qualifications and designations of the regular faculties holding sanctioned positions in the subject/ course concerned.

Any incomplete proposals shall be rejected and proposals shall have to submitted on or before the 10th May 2022(hard copy) and shall have to follow DU Syllabus and Regulations for the PG Programme, Any doubt may be clarified through email to office of the Inspector Of Colleges.
