## **NOTIFICATION**

This is information of all the selected Candidates that, the admission into the B.A. LL.B (Honours) Programme for the session 2022-2023 has been scheduled on 17<sup>th</sup> August, 2022 (for merit list) and 18<sup>th</sup> August, 2022 for (waiting list) through Offline Mode, at CJS, Dibrugarh University.

The merit list for admission is prepared without verifying the hardcopies of all relevant documents and anomaly detected subsequently as to the percentage / relevant matter for eligibility into admission based on required document(s) or as per Rules and Regulations shall entail the cancellation of admission immediately.

# (A) <u>Mandatory documents and information to be submitted (self attested) at the time of admission:</u>

- 1. Class 10<sup>th</sup> Marks Sheet and Pass Certificate.
- 2. Class 12<sup>th</sup> Marks Sheet and Pass Certificate.
- 3. Caste Certificate.
- 4. Permanent Residence Certificate (PRC)/ Local Man Certificate.
- 5. Hard copy of online generated Application Form.
- 6. Personal E-Mail id of the candidate with contact no. having WhatsApp.
- 7. Full Payment of fess shall have to be cleared at the time of admission and no request shall be entertained on any ground for any relaxation/extension of time. The candidates are advised to take necessary steps accordingly.

### (B) For candidates belonging to ST(H) category (Second Notice):

The candidates belonging to ST(H) and who are eligible for admission as per rules are requested to fill up online form from 11<sup>th</sup> August (evening) to 16<sup>th</sup> August 2022 as per our earlier notification vide no. DU/DR-A/Admission-BALLB(H)/22/713, Dated: 06/07/2022 and shall have to be present at CJS at 10.30 for admission on merit against three (03) vacant seats on 17<sup>th</sup> of August, 2022. Such candidates shall not require to appear in Entrance Test and shall fill up the application form for admission. If no candidates are available, seats will be converted to General Category and may be treated as of Endowment Category, which will be filled immediately and students shall have to pay Rs. 40,000 (Forty thousand extra for one time) in addition to payment admissible fee at the time of admission. The applications from the intending candidates shall be accepted offline on plain paper on 18<sup>th</sup> August 2022 (Up to 1 PM) from the students whose names have appeared in the list and admission shall be on merit.

### (C) For candidates belonging to EWS category:

The candidates belonging to EWS category and whose name have appeared in the list shall have to produce original certificate as per **University and Government Rule** in support of their claim and submit a self attested copy before the Admission Committee on 17<sup>th</sup> of August, 2022.

Fee Structure: First Semester @ Rs. 17,608/-

[Admission fee per year- Rs. 1,050/ + Course fee for per semester- Rs. 15,000/- + Other fees (Library, Development, Internet, Etc.) Per year- Rs. 1,558/-]

**Timing of Admission** – From 10.30 am onwards and shall be closed by 3pm and students shall have to respond immediately for admission after calling their name(S) in order and if not responded, the seat shall stand forfeited. Therefore they are advised to be present at the CJS by 10.30 am positively and to visit University website regularly for any information.
