## Terms of references:

1. The Committee shall adopt measures for prohibiting, preventing and eliminating the scourge of ragging in all forms in the University in accordance or compliance of UGC guidelines.

2. The Committee on receipt of the recommendation of the Anti-Ragging squad or on receipt of any information concerning any reported incident of ragging shall determine if a case under the penal laws is made out and if so, proceed to file First Information Report (FIR) within 24 hours of receipt of such information or recommendation.

3. The Committee shall recommend disciplinary action to the University authority if a student is found guilty of ragging.

4. The ARC shall remain valid for a period of 03 years or until further order whichever is earlier w.e.f. the date of issue of this notification.

This dissolve the earlier constituted Anti-Ragging Committee constituted as per notification no.DU/RG/G.01.01/22/5287 dated 13/09/2022
