#### Henceforth,

In FYUG Programme, both Paper Setting and Evaluation of Skill Enhancement Course (SEC) papers shall be done by the Colleges. However the paper setting for SEC on Library and Information Science will be done by the University. This paper shall be dispatched to the concerned examination centers exclusively by the University. In case of Environmental Studies (EVS) and Value Added Course (VAC), the Paper setting shall be done by the University and Evaluation shall be carried out at the respective colleges. Henceforth, both the evaluation work (non remunerative) of all SEC papers and VAC shall be carried out at the college level only.

Entries of all evaluated marks of VAC as well as SEC Papers of the concerned students at the college level shall be incorporated in the online mark entry software by the college itself through the respective course teacher/evaluator(s).
