



**UNDERTAKING ON 'RAGGING FREE HOSTEL', 'PROHIBITION ON THE USE OF MOTOR VEHICLE' AND 'PROHIBITION OF SMOKING, ALCOHOL & NARCOTIC CONSUMPTION'**

No. \_\_\_\_\_ hereby declare that, I have gone through the contents of the Hostel Rules 2015 (amended upto date) and understood it and undertake that, I shall abide by the Hostel Rules 2015 (amended upto date) in letter and spirit and shall not violate the provisions during my stay in the hostel. If found to violate the Rules, I shall accept any disciplinary action(s) imposed by the appropriate authority of the University.

1. That, I know that the Dibrugarh University strictly follows 'UGC Regulations on Curbing the Menace of Ragging in Higher Education Institutions, 2009' and the 'Judgment of the Hon. Supreme Court delivered on the 8<sup>th</sup> May, 2009. Further, it is incumbent upon me as the boarders of a Hostel to comply with the UGC Students' Anti Ragging Undertaking and the Parents Anti Ragging Undertaking. I undertake not to indulge in any form of ragging'.

2. I know that 'Possession and use of Motor vehicles by a bona-fide boarder of a Hostel is prohibited as per Clause 8(n) of the Dibrugarh University Hostel Rules, 2015 (amended upto date). As a boarder I shall not keep (including vehicles registered of persons other than the boarder) with me any motor vehicle during the stay in the hostel. If found guilty, I may be treated as and the offenders. The vehicle(s) shall be seized and handed over to the Security Officer for actions along with appropriate penalty as per rule laid down by the University from time to time.

3. I know that 'Smoking, Alcohol and Narcotic consumption is strictly prohibited in the hostel and possession, distribution and consumption of alcoholic beverages and illicit drugs in the hostels shall be treated as gross violation of Clause 12 (b) (ii), 15 (d) & (k) of the Dibrugarh University Hostel Rules, 2015 (amended upto date). I also know that consumption or storage or supply of liquor or any sort of intoxicant and entry into the hostel in an intoxicated state is strictly prohibited and the gambling is also prohibited in the hostel. If found guilty, the offenders will be dealt with severely, including prosecution.

4. I know that damage to hostel property including fixtures and furniture's of allotted hostel room is strictly prohibited in the hostel and changes in the electrical connection/load capacity in the hostel room by using heater or induction cooker shall be treated as gross violation of Clause 17 (h) of the Dibrugarh University Hostel Rules, 2015 (amended upto date). I also know that cooking of food in the hostel room is strictly prohibited as per hostel rule. If found guilty, the offenders will be dealt with severely, including prosecution

I declare that if I am found to violate any of the aforesaid rules, Wardens shall take appropriate steps to address such incidents including expulsion of the boarder(s). The decisions of the Chief Warden/Wardens shall be final and binding.
