NOTIFICATION

The 19th meeting of the Research Council, Dibrugarh University held on 26.06.2024 has adopted the following resolutions related to the Dibrugarh University Regulations for the Research Council and for the Degree of Ph.D. 2023 and Dibrugarh University Regulations for the Research Council and for the Degree of Ph.D. 2019 (amended upto date) under report to the next meeting of the Academic Council, Dibrugarh University.

Resolution No.09: Resolved that the duration of Ph.D. registration for the Research Scholars enrolled as per the Dibrugarh University Regulations for the Research Council and for the degree of the Doctor of Philosophy (Ph. D), 2019 shall be five (5) years from the date of registration.

However, the Ph. D. work of the aforesaid Research Scholars shall be regulated as per the provisions of the Dibrugarh University Regulations for the Research Council and for the degree of the Doctor of Philosophy (Ph. D), 2023.

Resolution No.10 (A): Resolved that women candidates and Persons with Disability (more than 40% disability) shall be allowed a relaxation of two (02) years for Ph.D. after completion of 7 (seven) years [(5 years of Registration and 2 years of Re-Registration (clause 22 (iv) of Dibrugarh University Regulations for the Research Council and for the degree of the Doctor of Philosophy (Ph. D), 2019)].

Further resolved that women candidates may be allowed to avail Maternity Leave / Child Care Leave once in the entire duration of Ph.D. for up to 240 days excluding nine (9) years [clause 22 (iv) of Dibrugarh University Regulations for the Research Council and for the degree of the Doctor of Philosophy (Ph. D), 2019]. However, such women candidates must Re-register themselves in the Ph.D. programme after completion of five (5) years to avail such leaves.

(B) Resolved that women candidates and Persons with Disability (more than 40% disability) shall be allowed a relaxation of two (02) years for Ph.D. after completion of 8 (eight) years [(6 years from the date of admission in the Ph.D.

programme and 2 years of Re-Registration (clause 22 (iv) of Dibrugarh University Regulations for the Research Council and for the degree of the Doctor of Philosophy (Ph. D), 2023)].

Further resolved that women candidates may be allowed to avail Maternity Leave / Child Care Leave once in the entire duration of Ph.D. for up to 240 days excluding ten (10) years [clause 22 (v) of the Dibrugarh University Regulations for the Research Council and for the degree of the Doctor of Philosophy (Ph. D), 2023]. However, such women candidates must Re-register themselves in the Ph.D. programme after completion of six (6) years to avail such leaves.

Resolution No.11: Resolved that every registered scholar shall present at least two papers during the tenure of her/his research at seminars organized by the DRC concerned.

Further resolved that papers presented by the Research Scholars in Seminars / Conferences other than above shall not be considered for the purpose (clause 23 (i) of the Dibrugarh University Regulations for the Research Council and for the degree of the Doctor of Philosophy (Ph. D), 2019 and Dibrugarh University Regulations for the Research Council and for the degree of the Doctor of Philosophy (Ph. D), 2023).

The above Resolutions shall come into effect from the date of issue of this notification. Issued with due approval.
