

**Policy Guidelines for Selection of Awardees of “The Teacher Award”
from the Affiliated Colleges of Dibrugarh University**

The Award: The ‘Teacher Award in Dibrugarh University’ is a noble initiative starting in the year 2023. The basic objective behind this award is to accord an honour to the teachers of the University so that they can get motivation and incentives to excel further in their work/duty. From the year 2024 this initiative has been extended to teachers of all Affiliated Colleges of Dibrugarh University for the same purpose. The award consists of The award will be conferred on the Selected Teachers every year on September 5, on the occasion of the National Teachers' Day.

Following categories of teachers may be considered for the selection of an awardee from each category:

- Assistant Professors (Stage-I) from the Discipline of Science.
- Assistant Professors (Stage-II) from the Discipline of Science.
- Assistant Professors (Stage-III) from the Discipline of Science.
- Assistant Professors (Stage-I) from the Disciplines of Humanities and Commerce.
- Assistant Professors (Stage-II) from the Disciplines of Humanities and Commerce.
- Assistant Professors (Stage-III) from the Disciplines of Humanities and Commerce.

For the selection of an awardee of the award, following eligibility criteria, evaluation parameters, application and selection procedures may be followed:

1. Eligibility Criteria

- (i) A teacher serving in a college affiliated under Dibrugarh University for at least 1 year can apply for the award.
- (ii) Teachers, who have already received this award earlier, shall not be eligible to apply again.
- (iii) Age limit should not cross 50 for the Assistant Professor on the last day of application.

2. Evaluation Parameters/Components

Applications will be evaluated for the Academic and Administrative Score (AAS) on the basis of four parameters/components. They are

- (i) Research Contribution (25% + 25% = 50% weight)
- (ii) Teaching Activities (30% weight)
- (iii) Administrative Responsibilities (10% weight)
- (iv) Co-Academic Activities (10 % weight)

Evaluation of parameters/components should be taken into consideration from the date of joining of the applicants as Teachers in Colleges with Dibrugarh University Affiliation.

The Research Score for Research Papers shall be augmented as follows: UGC-listed Journals/CARE Journals (Impact factor to be determined as per Thomson Reuters list):

- (i) Paper in UGC listed/CARE journals without impact factor: 5 points
- (ii) Paper with impact factor less than 1: 10 Points
- (iii) Paper with impact factor between 1 and 2: 15 Points
- (iv) Paper with impact factor between 2 and 5: 20 Points
- (v) Paper with impact factor between 5 and 10: 30 Points
- (vi) Paper with impact factor >10: 40 Points

The score division procedures for the Research Papers and Books/Chapters: **Two authors:** 70% of total value of publication for each author. **More than two authors:** 70% of total value of publication for the First/Principal/Corresponding author and 30% of total value of publication for each of the joint authors. **Same procedure** will be applicable for division of score in respect of Patent and Policy Documents etc.

Joint Projects: Principal Investigator and Co-investigator would get 70% and 30% each.

For Joint Supervision of Research Students, the formula shall be 70% and 30% of the total score for Supervisor and Co-Supervisor respectively.

Academic and Administrative Score (AAS) Evaluation Method: An Example

Parameters/Component	Cap as % of Cumulative Scores of different components
(i) Research Contribution (25 % + 25%):	50%
(ii) Teaching Activities:	30%
(iv) Administrative Responsibilities:	10%
(v) Co-Academic Activities:	10%

An example is given below to explain the method of calculating the final score:

<i>Parameters/ Components</i>	<i>Score submitted by an Applicant</i>	<i>Score awarded to the Applicant after applying respective weights</i>
<i>Research Contribution</i>	<i>120</i>	<i>60</i>
<i>Teaching Activities</i>	<i>60</i>	<i>18</i>
<i>Administrative Responsibilities</i>	<i>30</i>	<i>3</i>
<i>Co-Academic Activities</i>	<i>20</i>	<i>2</i>
<i>Total/Final</i>	<i>220</i>	<i>83</i>

So, the candidate under concern would get 83 out of 220 marks/score.

3. Procedure for Inviting Applications and Selection

- (i) Each year online applications will be invited in the month of June/July with a 21 days window. The applications must be forwarded by the Principals of the Applicants' Colleges. Hardcopy of the same must be submitted within 7 days from the last date of application to the office of the Registrar, Dibrugarh University.
- (ii) The applicant teacher must produce the "Vigilance Clearance Certificate" from the Principal of the concerned College.
- (iii) A Screening Committee consisting of 2/3 Deans of the Faculties, and Registrar will scrutinize the applications and compute the Academic and Administrative Score (AAS).
- (iv) A Selection Committee, consisting of at least 3 competent External Experts (among the leading Scientist/Social Scientist/noted Academician), will give an Expert Score (ES) to each of the candidate.
- (v) Finally, the Selection Committee will recommend the awardees considering the Academic and Administrative Score (AAS), and Expert Score (ES) in the ratio of 60:40.

(vi)The decision of the Selection Committee and University Authority will be final and binding.

The committee believes that the framed Policy Guidelines presented above would be an effective tool to select the Best Teachers among the Teachers from the said categories engaged in different Disciplines of Affiliated Colleges of Dibrugarh University without compromising the quality.
