The following applicants have been selected provisionally under an **endowment category based** on DUPGET 2024 score on merit basis to appear in the interview for taking admission into the **MA Programme in Education** for the session 2024-25, scheduled to be held on **5**<sup>th</sup> **August, 2024 from 10:30 A.M. to 11:30 AM** in the premises of the Department of Education, Dibrugarh University.

For admission under the **endowment category**, the students shall have **to pay endowment fee of Rs. 25,000.00** (rupees twenty five thousand) only, besides the admission fees.

#### **Admission Procedure:**

- The provisionally selected candidates shall have to be physically present in the Department of Education, Dibrugarh University, on 5<sup>th</sup> August, 2024, as per the scheduled time (10:30 am to 11.30 am) for counseling/verification of their documents. Candidates of waiting list are also to register their names in the Department on or before 10:30 am of 5<sup>th</sup> August, 2024. Admission of the candidates of the waiting list will be also held on the same date as per the vacancies after completion of the admission of the candidates from the merit list
- > The candidates provisionally selected for Admission under endowment category shall have to bring the following documents on the date of admission:
- *i.* A print copy of the Online Application submitted along with the photocopies of all relevant testimonials.
- ii. DUPGET, 2024 Score Card.
- iii. Graduation Mark sheet/Grade sheet and Pass Certificate.
- iv. Class 10<sup>th</sup> and 12<sup>th</sup> Mark sheet and Pass Certificate.
- v. Domicile Certificate/Permanent Residence Certificate (PRC) of Assam for availing the Fee waiver benefit.

- vi. Undertaking on 'Provisional Admission' (Format of undertaking shall be available in the University website). It may be pertinent to mention here that the provisionally selected candidates not submitting the final year/semesters Mark sheet/Grade sheet on the date of admission need to submit an undertaking as per the proforma available in DU website.
- vii. Gap Certificate wherever applicable (in the form of Affidavit).
- viii. All documents in original for producing before the Admission Committee.
- ix. The Admission Fee, Course Fee, etc. (as per the Fee Structure for the session 2024-2025 notified by the Registrar, D.U. vide no DU/RG/G.01.01/2024/6962, dated 02.07.2024) and endowment fee of Rs. 25,000/-

The Admission Fee, Course Fee, etc. (wherever applicable) to be paid by the candidates at the time of admission through online mode by using their Debit Card, Credit Card or internet banking.

- x. The Admission of the candidates shall be held in the respective Departments/Centres for Studies on the scheduled dates only.
- xi. The Selection and Admission of all Academic Programmes covered by this Notification shall be purely provisional and subject to fulfillment of requisite norms of Qualifying Examinations and other relevant criteria.

## **Accepted Modes of Payments:-**

- 1. Online Payment using Debit Card/Credit Card/ Internet Banking.
- 2. POS Machine using Debit Card/Credit Card
- 3. Cash deposit at the designated bank (least preferred mode)

### Instruction to the candidate:

- 1. **The candidate must keep handy**, duly sealed and signed original admission confirmation slip, the online application number/form, registered phone number for online transaction, valid Debit Card/Credit Card in order to avoid last minute rush.
- 2. The candidate intending to pay using Debit Card/Credit Card must ensure that, adequate **limit is provided by their host banks**. If adequate limit is not available on the card, the candidate is advised to do the same by following the instructions provided on the respective bank's website. The process of enhancing limit differs from one bank to the other.

- 3. The candidate must ensure that e-commerce transaction is allowed on their Debit Card by the respective host banks.
- 4. The candidate will be allowed to use any one of the modes of payment stated above. One mode of payment cannot be mixed with the other i.e. **the modes of payment are mutually exclusive.**

For example, suppose the admission fee is Rs. 35,000/- and a candidate has brought Rs. 25,000/- in cash and intends to pay Rs. 10,000/- using Debit Card/Credit Card, this will not be permitted in any case. The whole amount shall be accepted either using Debit Card/Credit Card or the whole payment shall have to be deposited in cash at the bank.

- 5. No candidate shall be treated as admitted, unless their enrolment ID is generated through ERP portal. Therefore, candidate has to ensure that, their enrolment ID is generated before leaving the University premises.
- 6. Cash payment shall have to be deposited at the designated bank/branch only. No other cash deposit shall be accepted. **Designated Bank for receiving Admission Fee in cash is Punjab National Bank, Dibrugarh University Branch.**

Note: 2. The merit of the Candidates securing the same score in DUPGET 2024 shall be determined on the basis of Marks secured in the Graduation.
