A. MINIMUM ELIGIBILITY CRITERIA

- The bidder shall be a Proprietor/ reputed firm(s) in Canteen / Catering services etc. having their business
 operations in canteen services in Assam.
- The firm shall submit the Earnest Money Deposit (EMD) of Rs. 25,000/- (Rupees Twenty Five Thousand Only) or EMD exemption certificate along with the relevant document (if any).
- Bidders shall have to meet the following pre-qualification criteria of having at least three (3) years of
 experience in maintenance of Canteen Services/Catering Services.
- 4. Bidder should not have been blacklisted on any score by any Government Department/Institution/ Autonomous Body/Public Sector Undertaking. Any information in this regard subsequently found to be incorrect after submission of bid or award of contract will entail rejection of the bid or cancellation of Award of Contract as the case may be.
- In proof of having fulfilled the minimum eligibility criteria mentioned, the legible scanned copies of the following self attested documents/information must be submitted with the Technical Bid.
 - a. Copy of GST, certificate of incorporation issued by the Registrar of Companies and firm registration certificate.
 - b. Copy of FSSAI should be submitted.
 - c. Copy of PAN should be submitted.
- 6. Bidders may note that bids are to be submitted as per the instructions laid out of this tender document. The selection of successful bidder would be in two steps:
 - a. Technical Bid
 - b. Financial Bid

B. SUBMISSION OF TECHNICAL BID

C. EVALUATION OF BIDS

A two-stage procedure will be adopted in evaluating the proposals with the Eligibility criteria evaluation and technical evaluation completed entirely prior to any financial proposals being opened. Eligibility criteria and Technical Evaluation documents will be evaluated to ensure that all the stated criterions are met.

DESCRIPTION OF THE SELECTION PROCESS

STEP 1: RESPONSIVENESS OF RID

The Bids submitted by Bidders shall be initially scrutinized to establish "Responsiveness". A Bid may be deemed "Non-responsive" if it does not satisfy any of the following conditions:

- a. It is not received by due date and time as specified in this bid document.
- b. Conditional offers or if it does not contain sufficient information for it to be evaluated and/or is not in the formats specified
- c. It is not signed and /or sealed with stamp impression.

A bid once declared as "non-responsive" and rejected, cannot be made responsive by the bidder having corrected or withdrawn the non-conforming deviation or reservation

Note:

The University reserves the right to:

- i. Accept/reject any/all tenders without assigning any reason thereof.
- ii. Revise the quantities at the time of placing the order without change in the rate quoted by the bidder.
- Add/modify/relax or waive any of the conditions stipulated in the tender document whenever deemed necessary

E. TERMS & CONDITIONS FOR CATERING SERVICES TENDER

- 1. The bidder should have a catering set up in Dibrugarh.
- The tenderer should go through the complete tender document including all Terms & Conditions stated by Dibrugarh University before tendering.
- 3. The selected bidder shall be absolutely 'a bare license' and anything contained therein shall not be deemed to give any right in law in respect of the said premises fittings, fixture and other University belongings to the Bidder in any manner.
 - a) Selected bidder shall set up the food court in specified space provided. The food court should have a seating capacity with table for 50 people and without table for another 50 people. Food court should be decorated in a decent manner with sufficient lighting, fans and wash basins, etc.
 - b) Average numbers of meals per session may range from 250 to 300 nos. There should be minimum of two buffet counters to serve food simultaneously. Food should be of good standard and must be prepared following proper hygienic condition.
 - c) The selected Bidder shall use decent crockery sufficient for the use of 350 persons at a time and good stainless steel utensils will be used for serving meal.
- 4. The Bidder shall have to quote on per plate basis and per bottle/glass basis as mentioned in the particulars above.
- 5. The Bidder shall have to arrange the required gas cylinders for the said purpose without fail.
- 6. To ensure safe & potable drinking water, the selected caterer shall arrange branded drinking water.
- The selected bidder shall not sublet/ permit the said catering service and in default thereof shall be liable for cancellation of award of work.
- The selected bidder shall ensure hygienic conditions and shall have to comply with the instructions issued from time to time by Dibrugarh University or by an Officer/Committee nominated by Dibrugarh University on this behalf.
- The cooking oil/ refined/ butter/ ghee shall be of standard quality. Inspection by competent authorities shall be carried out without prior information to the selected bidder.
- 10. The food, water, ingredients etc. served by the selected bidder shall be obtained by him/her from the approved sources and shall be fresh, hygienic wholesome of good quality of their respective kind and of reasonable quantity. If on examination, it is found that food items / articles kept are exposed to dust, flies or the services rendered by the selected bidder is unsatisfactory then the license shall be revoked, and the selected bidder shall be even prosecuted under the provision of Prevention of Food Adulteration Act and shall also be liable to pay a fine of not less than Rs. 50,000/- (Rupees Fifty Thousand only) to Dibrugarh University and may also face prosecution under relevant Acts/ Laws of land.
- 11. The selected Bidder shall ensure that persons not below a prescribed age of 18 years, and as may be permissible under the relevant law, are employed. Labour Law regarding appointment/wages etc. be followed.

- 12. The dealings of the selected bidder and his workers with the Staff & the attendees shall be polite and courteous. The selected bidder shall not be permitted to exhibit in the said premises any printed or written notice, advertisement, posters etc. of any kind and any company whatsoever.
- 13. The selected bidder shall not carry out any illegal act or objectionable items or commodities in or outside the premises, which may be nuisance or a cause of annoyance to the students/attendees/Guests/staff of Dibrugarh University.
- 14. On the expiry or earlier termination of this order, the premises shall be vacated peacefully by the Caterer and he/she shall clean the venue before vacating them.
- 15. Any notice to be given to the selected Bidder under the terms of this license shall be considered to be duly served & the same shall have been affixed on outer door any other conspicuous part of the said premises. The selected bidder shall ensure proper cleaning in and around the cooking area. The Kitchen waste shall be disposed off through covered containers in the dustbin situated in the nearby area.
- 16. The Annexure-A (Financial Bid) shall be sealed in separate envelope. Before, this envelope is opened, Technical Evaluation shall be done by Dibrugarh University for all. Financial/Price Bid shall be opened only for those agencies who qualify the quality standards and finally the tenders shall be decided.
- 17. The contract will be awarded for three days i.e. 11th November to 13th November, 2024 only so as to prepare and cater the meal for the attendees/Guest/staff of Dibrugarh University. Any dispute arising out of this contract shall be subject to Dibrugarh Jurisdiction only.
- 18. The selected bidder will deploy adequate number of manpower to serve the attendees/Guests/Staff.
- 19. The quantity of meal/plates/glass/bottles may increase or decrease depending on the attendance of the attendees/guests/staff and the selected bidder shall agree to serve meal to the attendees/guests/staff without fail. He/she shall ensure that sufficient amount of food is available to serve the attendees/guests/staff.
- 20. The selected bidder shall have to sign a Letter of Acceptance as indicated in ANNEXURE-B of this Tender.
